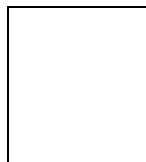

1. BANKSETA BACKGROUND

- 1.1 BANKSETA is a statutory body established through the Skills Development Act of 1998 to enable its stakeholders to advance the national and global position of the banking and micro-finance industry. As guided by its mandate the BANKSETA is an agent of transformation and will promote employment equity and Broad Based Black Economic Empowerment through skills development.
- 1.2 BANKSETA is a schedule 3A public entity with about 92 staff complement. BANKSETA has a head office in Gauteng at 349 Witch-Hazel Avenue, in Eco Park, Centurion, a satellite office in Free State and two regional offices, one in Limpopo and the other in Eastern Cape.

2. PURPOSE AND OBJECTIVES OF THE PROJECT

- 2.1 The BANKSETA seeks to appoint a panel of service providers in relation to Internal Audit (IA) services covering Internal Audit and Information Communications Technology (ICT) Audit Services.
- 2.2 BANKSETA has an in-house Internal Audit Division with three staff members who execute a Rolling Three-Year Strategic Internal Audit Plan approved by the BANKSETA Audit and Risk committee. For a number of reasons, BANKSETA may not have adequate resources or skills for some internal audit work.
- 2.3 The BANKSETA will appoint a panel of ten (10) service providers. All panel members will be required to quote through a competitive Request for Quotation (RFQ) process for each piece of work to be done. The award for work will be to the highest scoring quote/bid.

3. SCOPE OF WORK

The scope of work should include, but is not limited to the following:

- 3.1 The service provider (s) shall execute allocated audit assignments at the BANKSETA in line with the International Standards of Professional Practice and Code of Conduct as set by the Institute of Internal Auditors and other applicable professional standards, where applicable.
- 3.2 The service provider (s) shall execute allocated audit assignments at the BANKSETA in line with relevant legislation including Public Finance Management Act, National Treasury Regulations, Skills Development Act and Skills Development Levy Act amongst others.
- 3.3 The service provider(s) shall provide the BANKSETA with skilled and experienced auditors and supervisors to conduct internal audit projects according to the internal audit plan that may include the following areas:
 - (a) Internal Audit (this includes, but are not limited to, risk-based audits on the Financial, Human Resource, Performance Information, Supply Chain Management processes, Mandatory Grants, Discretionary Grants and Commitments);

- (b) Compliance audits (this includes but is not limited to POPIA, Skills Development Act and Skills Development Levy Act audits);
 - (c) Performance audits;
 - (d) Enterprise Risk Management, Governance and Ethics Reviews; and
 - (e) Information Communications Technology (ICT) Audits (this includes but is not limited to General Control, Application Control, Cyber Security, Infrastructure and Pre and Post Project Implementation reviews).
- 3.4 The service provider(s) shall conduct follow up audits on the implementation of agreed audit action plans;
- 3.5 The service provider(s) shall assist the BANKSETA to strengthen its internal control environment by considering fraud risks in allocated audit projects;
- 3.6 The service provider(s) shall apply and uphold the best practice guiding principles;
- (a) Professionalism and Diligence: The service provider(s) shall at all times, demonstrate a commitment to professionalism and diligence in the performance of his or her duties.
 - (b) Legal and Ethical: The service provider(s) shall not engage in any illegal or unethical conduct, or any activity which would constitute a conflict of interest.
 - (c) Integrity: The service provider(s) shall at all times, exhibit the highest level of integrity in the performance of all professional assignments and will accept only assignments for which there is reasonable expectation that the assignment will be completed with professional competence.
 - (d) Objectivity: The service provider(s) shall perform its work without bias or prejudice.
 - (e) Confidentiality: The service provider shall at all times, maintain the highest level of confidentiality in the performance of services by ensuring that there is limited access to information shared with the service provider.
 - (f) Competency: The service provider(s) shall apply the necessary knowledge, skills, and experience needed in the performance of internal audit services.
- 3.7 The BANKSETA will be appointing up to ten (10) service providers. All panel members will be required to quote through a closed Request for Quotation (RFQ) process for all pieces of work required. The award for work will be to the highest scoring quote/bid.

The following deliverables are expected to be produced for each allocated assignment within the agreed timeframes:

- detailed audit report using the BANKSETA Internal Audit Methodology.
- A reviewed audit file that includes the planning, execution and reporting according to the BANKSETA IA Methodology after the clearing of review notes.
- Control implications based on the findings.
- Recommendations to correct identified control weaknesses.

- The service provider is expected to present and discuss the completed work to management, Board Sub-Committees (including Audit and Risk Committee) and the Board (depending on the nature of the review performed).

4. COMPETENCY AND EXPERTISE REQUIREMENTS

- 4.1 The Service Provider(s) should have verifiable experience within the internal audit environment of providing internal audit services for at least five (5) years and provide company registration documents to support the date of registration.
- 4.2 The Service Provider (s) must provide a brief profile summarising the credentials of the team to be assigned to this work as well as their areas of specialisation. The team must comprise of at least 3 persons being a Team Leader and at least 2 additional team members. The bidders should submit copies of the qualifications, memberships certificates and the CVs for all the team members proposed showing audit experience...The service provider should clearly indicate which team members will be assigned to team Leader and to Team Member.
- 4.3 Team Leader – The Team Leader should be an existing employee of the Service provider.
 - 4.3.1 Team Leader - The appointed team leader should be in possession of at least one of the following designations :
 - Chartered Accountant of South Africa (CA(SA));
 - Association of Chartered Certified Accountants (ACCA);
 - Certified Internal Auditor (CIA); Professional Internal Auditor (PIA);
 - Certified Information Systems Auditor (CISA),
 - Certified Information Systems Security Professional (CISSP),.and
 - Registered Government Auditor (RGA).
 - 4.3.2 Team Members - The Service Provider should assign a team to the project with a Team Leader that has at least 5 (five) years of audit services experience.
 - 4.3.2.1 Team members qualification - The Service Provider must provide team members in possession of minimum of NQF level 7 qualification or higher in any of the following fields
 - auditing field
 - Information Technology Auditor
 - finance or accounting and
 - be registered with any relevant professional body (i.e IIA Institute of Internal Auditors and ISACA).
 - 4.3.2.2 Team members experience – The Team members should have 3 years audit experience.
- 4.4 The Service Provider should have experience in conducting Internal Audit services and must have a proven track record for providing Internal Audit service to the public sector in

South Africa. The organisation responding must provide a minimum of 3 (three) written reference letters from different clients (on client letterhead) where Internal Audit services has been conducted in the past four (4) years (from 2020).

he reference letters must include:

- (i) the Client company name,
- (ii) the client contact name and/or position,
- (iii) the client email address or telephone / cell phone number,
- (iv) type of work/ service conducted,
- (v) the year the work / service was done. and
- (vi) Be signed and dated.

At least one of the 3 minimum reference letters must be related to ICT Audit Services.

5. DURATION OF THE CONTRACT

The contract will be valid from the contract signing date by both parties for a period of three (03) years.

6. PRICING STRUCTURE

- ***N.B: The Pricing Schedule must be completed as per the attached annexure A. Bidders who failure to comply with this requirement may be disqualified because it will be impractical to compare across all submissions.***
- ***BANKSETA will allocate estimated hours to the listed activities. The calculated price as per Annexure A will be used for price comparison and evaluation purposes only.***

- 6.1 The attached pricing sheets (Appendix A) should be completed in full. The BANKSETA will not entertain pricing adjustments after the signing of contract, and it is therefore important that all pricing elements are disclosed.
- 6.2 The pricing sheet should show VAT separately.
- 6.3 All pricing assumptions excluded costs and estimated costs should be clearly documented. The BANKSETA assumes that the pricing document as supplied is complete and covers all costs associated with this project.
- 6.4 The service provider will be requested to provide a quoted proposal regarding the work to be undertaken for each project.
- 6.5 The total cost must be VAT inclusive and should be quoted in South African Rand (i.e. ZAR).
- 6.6 The service provider should provide hourly rates. The BANKSETA uses the Auditor- General of South Africa (AGSA) rates as the ceiling price for outsourced work. These prices are used as a benchmark as there are no prescribed hourly rates from the IIASA or ISACA (SA).
- 6.7 Service providers are allowed to and are encouraged to provide a discount to the proposed AGSA hourly rates.

- 6.8 Wherever necessary, the service provider should provide accommodation, travel and subsistence rates that are aligned to the National Treasury instruction note. The current National Treasury Instruction in effect is note No. 07 of 2022/2023 and annexures.
- a. Air travel must be restricted to economy class.
 - b. Claims for kilometres may not exceed the rates approved by the Automobile Association of South Africa.

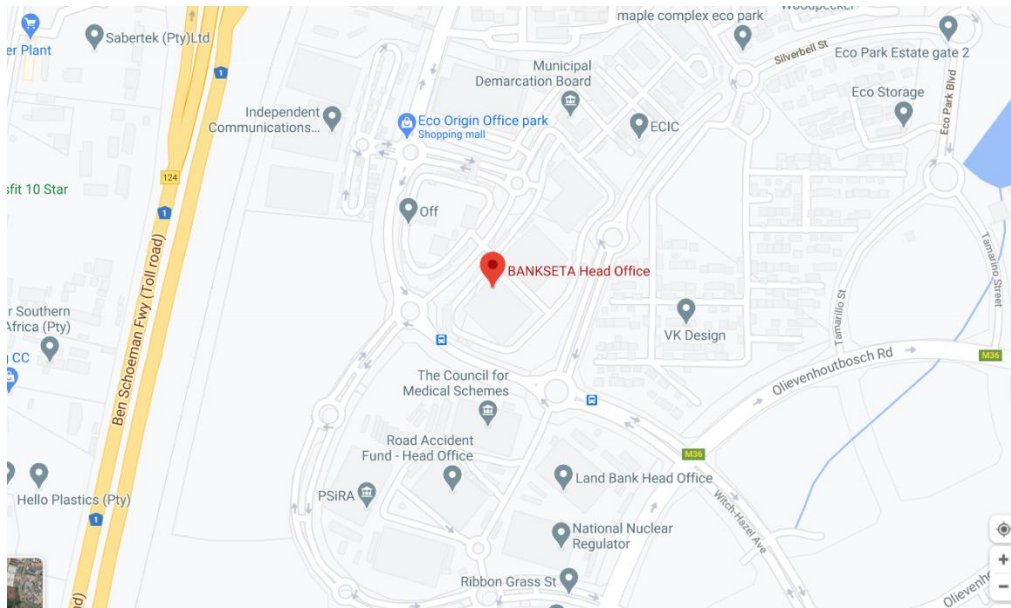
- 7.1 All submissions should be delivered in individual envelopes as per clause 7.4 and 7.5 below.

- 7.3 The BANKSETA reserves the right to reject any submissions if there are discrepancies identified in the submissions thereto.

9. TENDER EVALUATION/ADJUDICATION

Bids will be evaluated in three phases:

- 9.1 Compliance/eligibility (Bids that do not pass the compliance eligibility evaluation will be disqualified from participating in the next evaluation stage)
- 9.2 Technical/Functionality (Bids that do not meet the minimum threshold indicated in technical/function evaluation - clause 12 will not participate in the final evaluation stage)
- 9.3 Price and BANKSETA Preferential Procurement points (Bidder will be appointed on the highest scores)

10. COMPLIANCE STATUS

- 10.1 The service provider should be registered on the Central Supplier Database (CSD) maintained by the National Treasury and accessible on www.treasury.gov.za
- 10.2 The BANKSETA, before making an award, shall check on the central supplier database (CSD) whether;
- (a) the bidder or any of its directors are not listed / indicated as restricted from doing business with the public sector, and person prohibited
 - (b) the bidder's tax status is compliant.
 - (c) the bidders, its directors or management are not employees of the state, or if a director is an employee of the state, the service provider and or directors have permission to do business with the state, as provided for in the legislation.
- 10.3 The BANKSETA will not award any bids to service providers who do not comply with the above.
- 10.4 The BANKSETA will afford bidders a chance to clarify and provide evidence where there is any adverse information on the CSD reports.

13.1 PREFERENCE POINTS UTILISING BANKSETA GOALS

In terms of Gazette 2721, the BANKSETA has allocated preference points to be awarded to tenderers who meet certain BANKSETA Goals as follows:

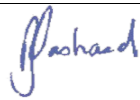

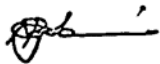
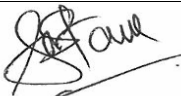
